Methods and assumptions used to determine contribution rates:

Table listing methods and assumptions: Actuarial cost method (Ultimate Asset Reserve), Amortization method (N/A), Remaining amortization period (N/A), Asset valuation method (Five year smoothed market), Inflation (3.00%), Salary increases (4.00 – 5.50%, including inflation), Investment rate of return (7.75%, net of pension plan investment expense, including inflation).
